

1. SUBJECT

Timelines for processing Eskom's 2018/19 RCA application.

2. PURPOSE

The purpose of this publication is to inform stakeholders and affected parties of timelines and determination process on Eskom's 2018/19 RCA application.

3. INTRODUCTION AND BACKGROUND

The National Energy Regulator of South Africa (NERSA) is a regulatory authority established as a juristic person in terms of Section 3 of the National Energy Regulator Act, 2004 (Act No. 40 of 2004). NERSA's mandate is to regulate the electricity, piped-gas and petroleum pipelines industries in terms of the Electricity Regulation Act, 2006 (Act No. 4 of 2006), Gas Act, 2001 (Act No. 48 of 2001) and Petroleum Pipelines Act, 2003 (Act No. 60 of 2003).

On 8 August 2019 NERSA received Eskom's RCA revenue application for 2018/19 financial year, requesting total RCA balance of R 27 323 million.

NERSA conducted a screening to ensure that the application is compliant with the fourth Multi Year Price Determination (MYPD4) methodology and Minimum Information Requirements for Tariff Application (MIRTA) requirements. After several interactions with the applicant, Eskom submitted a revised application on 13 November 2019. Full compliance was confirmed on 19 November 2019 after all outstanding information was submitted by Eskom and further verification was conducted by NERSA.

4. ANALYSIS OF ESKOM'S RCA APPLICATION FOR 2018/19 FINANCIAL YEAR

The Energy Regulator will assess Eskom's application following due regulatory processes. The indicative timelines for the decision-making process is provided in Table 1 below.

4. NERSA's Electricity Subcommittee (ELS) to consider draft Reasons for Decision	18 March 2020
5. Energy Regulator decision on Eskom's RCA application	24 March 2018
